Any student new to the district must bring a birth certificate and social security card to enroll.

FAMILY EDUCATION RIGHTS & PRIVACY ACT

Under the provisions of the Family Educational Rights and Privacy Act (FERPA), parents of students and eligible students (those who are 18 or older) are various rights with the regards to educational records which are kept and maintained by USD 307. In accordance with FERPA, you are required to be notified of those rights that include:

- 1. The right to review and inspect all of your educational records except those that are specifically exempt. Records will be available within 45 days of the day the district receives a request for access.
- 2. The right to prevent disclosure of personally identifiable information contained in your educational records to other persons with certain limited exceptions. Disclosure of information from your educational records to other persons will occur only if:
 - A. We have your prior written consent for disclosure, or
 - B. The information is considered "directory information" and you have not objected to the release of such information.
- 3. The right to request that your educational records be amended if you believe the records are misleading, inaccurate, or otherwise in violation of your rights. This right includes the right to request a hearing at which you may present evidence to show why the record should be changed if you request for an amendment to your records is denied in the first instance.
- 4. The right to file a complaint with the Family Policy and Regulations Office at the U.S. Department of Education if you believe that USD 307 has failed to comply with FERPA's requirements. The address of this office is 400 Maryland Ave., SW, Room 4074, Washington, D.C. 20202-4605.
- 5. The right to obtain a copy of USD 307 policies for complying with FERPA. A copy may be obtained from the Ell-Saline USD 307 District Office, 412 E. Anderson, PO Box 157, Brookville, KS 67425-0157.

Appointments and Adoptions—The yearly appointments and adoptions were made. All meal prices increased by \$.10.

School Food Service Agreement—This was approved.

Board Policy 2nd Reading—The 2nd reading of new board policy GAAF Emergency Safety Interventions (ESI) was held.

Approve Handbooks—All handbooks were approved as presented.

Set Budget Hearing Date and Time—The Budget Hearing was set for 6:45 p.m. on Monday, August 12, 2013.

Classified and Administrative Salaries—Classified and Administrative salaries were approved at 1.3% increase which is the same as that of returning teachers.

Supplemental Position—Kris Bell and Darcy Bradley were approved as MS Cheerleader Co-Sponsors.

Accept Resignations—The following resignations were accepted: Emeryld Wills as MS/HS Title Math Para; Donna Trowbridge with liquidated damages as 1st Grade Teacher; and Susan Rose's retirement as Board Clerk effective November 1, 2013.

Kindergarten Payment Schedule—It was approved to reduce the time from 1-month to 2-weeks for overdue balances to result in a student enrollment being reduced from attending all-day to only half-day.

Ratify Negotiations—Negotiations with the Ell-Saline KNEA were ratified.

Elementary School Parking Lot Drainage—Permission was given to the superintendent to secure and approve bids for a drainage project and, if under \$20,000, to approve the low bid but if over \$20,000 to have a special meeting called for the purpose of approving bids.

There were two Executive Session (Negotiations, Personnel).

The meeting adjourned at 9:06 p.m.

AN ENTITLEMENT PROGRAM OF GREAT IMPORTANCE



The importance of the Free and Reduced Breakfast/Lunch program continues to grow. This program was established and is funded at the federal level. It is a program that enables some students to eat at reduced rates and other students to eat free, and has become a guideline for determining amounts of money allotted to our district in two other programs: 1) At-risk student education program, and 2) E-rate funding for the district.

Last year 48% of our elementary students and 35% of our MS/HS students qualified to participate in the Free and Reduced Breakfast/ Lunch Program. Our overall district participation was 42% of our students. The elementary percentage was up considerably from the year before whereas the MS/HS percentage stayed the same. The more students that participate in the Free and Reduced Breakfast/Lunch program, the more funding we receive from federal sources to fund our "At-Risk" and "E-RATE" programs. The more funds we receive from them the less we have to come up with locally. It is important to our district for all families that meet the guidelines given at the end of this article to fill out and turn in an application. All applications are kept in strict confidence so that no other students or unauthorized school personnel know who has gualified.

The finance formula passed by the legislature last spring places even more emphasis on the Free and Reduced Breakfast/Lunch Program numbers. For students that qualify for this program, we will again receive an additional funding weighting of 45.6%. The amount this generates hardly keeps up with our increased costs. My guess is that if everyone that meets the guidelines would fill out an application, we would see a considerably larger increase in funding—at no cost to our local taxpayers and patrons—and at a savings to those households that qualify.

Please review the following criteria, and if you think you might qualify and have not applied, please call Susan Rose in the district office at 785-225-6813 for your application today! An application has been mailed to all parents of students that attended our schools last year. All applications are kept in strict confidence.

Free and Reduced Price Meals

* If you now receive Food Stamps, Temporary Assistance to Families (TAF), or Food Distribution Program on Indian Reservations (FDPIR) for your child(ren), they are also eligible for Child Nutrition Program free benefits. Refer to application.

* If your total household income is at or below the amounts on the Income Chart, your child(ren) can get free meals, or pay 40 cents for reduced price lunch and 30 cents for reduced price breakfast. Refer to application.

ASBESTOS NOTICE TO STUDENTS, PARENTS, EMPLOYEES, AND CONTRACTORS OF USD 307 ELL-SALINE SCHOOLS



In accordance with Federal Regulations as put forth in AHERA, USD 307 has filed a management plan with the State of Kansas on or before October 12, 1988. This report contains information about the location of all asbestos containing materials located within the buildings of the district. There were only a few areas of the building that contained highly friable asbestos. By school, those are:

Ell-Saline Elementary

Pipe insulation elbows in custodial room, and pipe chase.

Ell-Saline Middle/High School

No highly friable asbestos.

Non friable asbestos containing materials have been identified in both buildings. All entrances to areas where friable asbestos is identified, as well as specific spot notices for workers will be marked. All suspected asbestos containing materials are monitored on a regular basis and should they become hazardous will be properly removed.

Inspections occur per the requirements of the regulations. All patrons of the district will be informed annually via the newsletter of the status of the program.

As long as the asbestos is monitored properly and is not disturbed, unless by properly trained personnel, there is no safety risk. A copy of all inspection reports and results is on file in each building as well as the central office. This information is available to all interested parties within a reasonable amount of time after a request. If you should have any questions about asbestos in our district, please do not hesitate to call the superintendent of schools.

BUS TRANSPORTATION

Bus routes are mapped with primary regard to safety, efficiency, and economy. Buses will be routed as close to homes as possible,



but other considerations may make it necessary to have children walk a short distance. By Kansas law, whenever practicable, no student will be compelled to walk more than one mile to board a school bus. As done in past years, buses will not be entering private drives unless they are utilized as a route turn-around or for safety. Students will be required to meet the bus at the roadway.

At certain times of the year the county roads may be in bad condition. During such times, it may become necessary to alter routes to avoid placing buses in dangerous situations.

By Kansas law, all students living two and one-half miles and over from the school will be transported to and from school.

SEASONS START WITH SCRIMMAGE



The football and volleyball seasons will officially begin on **August 19th** for high school students. Everyone needs to have a physical examination by a licensed physician and have a parent or guardian sign the form. Athletes will not be allowed to practice until their physical forms are signed.

Practice times for high school football and volleyball will be posted at enrollment.

On Friday, **August 30, 2013** there will be a Gatorade scrimmage for high school volleyball beginning at 5:00pm with the football scrimmage beginning at 6:00pm. DIRECTORY INFORMATION

For purposes of FERPA, USD 307 has designated certain information contained in educational records as directory information which may be disclosed for any purpose without your consent. The following information is considered directory information: name, address, telephone number, date and place of birth, participation in officially recognized activities and sports, weight and height of members of athletic teams, dates of attendance, degrees and awards received, the most recent previous school attended by the student, class designation, major field of study, and photographs.

You have a right to refuse to permit the designation of any or all of the above information as directory information. If you refuse, you must file written notification to this effect with USD 307 at 412 E. Anderson, PO Box 157, Brookville, KS 67425-0157 on or before August 30, 2013. If a refusal is not filed, USD 307 assumes you have no objection to the release of the directory information designated.

PROFESSIONAL QUALIFICATIONS OF ELL-SALINE STAFF

Credential

Parents may request information regarding the professional qualifications of their child's/children's classroom teachers and paraprofessionals.

Professional qualifications include:

• Whether or not the teacher has met Kansas licensing criteria for the grade levels and subject areas being taught.

- The baccalaureate degree and any other graduation certification or degree and the field of discipline for both.
- If services are provided by paraprofessionals, their qualifications.

• If the teacher is teaching under an emergency or professional waiver.

LAW REQUIRES PROOF OF IDENTITY



Kansas law states "Whenever a child enrolls in school for the first time, the board of education is required to secure proof of identity of the child..." The district will accept the following documents as proof of identity: birth certificate, baptism or hospital record, copy of court order awarding custody, certified transcript or similar pupil record.

If proof of identity is not provided within 30 days, the board must notify the local law enforcement agency.

IMMUNIZATION REQUIREMENTS



All students entering or enrolled in Kansas schools must have the following immunizations: measles, rubella, DTP (diphtheria, tetanus, whooping cough), oral polio, and mumps. A card signed by a physician or authorized proof from a health clinic is required. All students entering kindergarten are encouraged to complete the Hepatitis B vaccination series. Immunization forms will be available at enrollment.

The Salina-Saline County Health Department can provide both the immunizations and the certificate necessary for students to enroll. There is a \$20 fee for each immunization. However, if your physician gives immunizations, and you have insurance that covers the expense, you are asked to have your physician give the immunization. (Comcare physicians are now providing this service to their clients.)

The health department is located at 625 E. North St. in Salina (785-826-6602). Immunizations will be given at the following times:

- Monday's and Tuesday's...... 8:00 am to 3:30 pm
- Wednesday's..... 8:00 am to 5:30 pm
- Friday's 8:00 am to 12:30 pm

By Kansas law, students who do not have the required immunizations within 90 days from the time of enrollment must be excluded from school.

FROM THE SUPERINTENDENT'S DESK

What a difference a year can make! At this time last year the ponds were drying up and the grass was brown in desperate need of some rain. Although there are cracks in the ground this year at least the ponds have water in them, the grass is green and it was a bountiful wheat harvest. We are still in need of timely rains for the fall crops but everything looks more optimistic than last year.

The custodians (David, Merle, Spencer, Zandra, Albert, Trena) are doing a great job of "cleaning up and sprucing up" all of the buildings and grounds. Their efforts show a great sense of pride in the work they are doing and it will present a positive image of the district to everyone who visits us. Brian and Danielle are busy with the yearly servicing and maintaining of our hardware and software. Another successful summer school session by many of our elementary school teachers is taking place and drivers' education is drawing to a close. Here in the office the vast majority of the textbooks and materials that were ordered have arrived and Lynn has processed them and they've been sent to the buildings. Ann is in the process of closing out last year's budget and is starting to set up next year's. Susan has updated the numerous handbooks and is preparing the forms and information that is needed for enrollment. New staff members have been interviewed and hired. We continue to interview applicants for our open 1st Grade and full-time At-Risk Reading/Math position at the Middle/High School. People sometimes ask whether the District Office is open during the summer. In many ways summer is the busiest time of the year in this office.

One of the tasks that keep us busy each summer is getting increasingly more difficult to do. That is in setting next year's budget and the reason is that we continue to have less of a budget to work with. Following several years of budget cuts and no increase in the Base State Aid Per Pupil (BSAPP) this year it is getting harder to balance needs with resources. The prior years' cuts have caused us to have lesser amounts in the General Fund and LOB to purchase materials, supplies, equipment, etc. and make additional transfers after making the budgeted transfers. At the end of the 2008-2009 school year we had \$580,000 and this year we are down to approximately \$100,000 to use for those purposes. Couple that lesser amount with ever increasing costs in fuel, utilities, insurance, etc. our budget will be really tight this year. Our challenge lies in determining what services, what materials, what professional development opportunities, what utilities, what positions, etc. can we cut back on and still provide what our students need. Balancing our students' needs with maintaining a stable mill levy is always our objective. It is our hope that we will be able to keep our mill levy very close to where it was last year.

Something else that keeps us busy is in preparing for the start of the new school year. Although it's hard to imagine, in just a few short weeks school will be starting.
