- **A.** Accept Resignation Motioned by Cheryl Higgins, seconded by Jamie Bradley to accept Trena Carlson's resignation effective October 21 as the elementary school evening custodian was accepted. Motion carried 6-0.
- **B.** Approve Supplemental Positions Motioned by Jamie Bradley, seconded by Mitch Drees to accept Chantay Seim was an Asst. HS Girls' Basketball Coach and Tracer Paul was as an Asst. HS Boys' Basketball Coach. Motion carried 6-0.

- C. Track Surface Options Motioned by Jeff Parker, seconded by Mitch Drees to accept the combined bid from APAC and United Sport Systems to seal the cracks, apply a 1.5" asphalt overlay and a .5" rubberized surface on the existing track at a cost of \$136,963.60 was approved. Weather permitting the crack filling and asphalt overlay will be done this fall and the rubberized overlay will be applied after the temperatures have warmed up next spring. This will be paid for out of the Capital Outlay fund. Motion carried 5-1 (John Fouard).
