Project consists of six separate bids. Bid A is for the repair or replacement of the subsurface as needed and application of an impermeable and permeable polyurethane running surface on the oval, chutes and runways. Bid for both types of surfaces may be submitted separately and both bids will be considered. Bid B is for the enlargement of the current high jump area. Bid C is for the addition of a Long Jump / Triple Jump Runway and two pits. Bid D is for the addition of a Pole Vault area. Bid E is for the addition of one shotput and/or two shot put areas. Bid F is for combination of Bid A, Bid B, Bid C, Bid D and Bid E. All bids should be submitted by November 11, 2022 at 12:00 p.m. All construction should follow the National Federation of High School Sports (NFHS) regulations for track facilities. USD 307 Ell-Saline has a six-lane track. Project must be completed between June 1, 2023 and March 1, 2024. Any variations to the Request for Proposals should be clearly identified.

#### A(1). IMPERMEABLE SURFACE USING CURRENT SUBSURFACE

- Cleaning and removing all surface material from the track oval, chute, high jump and runways;

#### A(4) PERMEABLE REPLACING THE SUBSURFACE

This would include all aspects of the high jump surface including removing the current subsurface and surface material from the high jump area; Replacement of the substructure base of the high jump area as needed per the proposed track system (Minimum of 3 inches); Application of Synthetic surface of the same structure as proposed for the track oval and chute. This bid should not include the high jump landing pits/foam padding, standards or poles.
- C. The addition of a long jump/triple jump runway and landing pits just South of our current long jump/triple jump runway and landing pits complete with subsurface (minimum of 3 inches). Runway should be at least 130 feet in length and 48 inches wide. Application of synthetic surface of the same structure as proposed for the track oval and chute including jumping boards and painted lines per NFHS regulations. Location of the long jump/triple jump runway and landing pits per attached diagram.

- D. The addition of pole vault pad surface and runway. The Pole Vault pad area and runway will need to be built to NFHS specifications. Proposal should include a concrete runway (4'x130') (minimum of 3 inches in depth.; two concrete pole vault pads (20' x 26.5') and Pole Vault Boxes. This bid should include all aspects of the pole vault surface including the substructure base and application of synthetic surface of the same structure as proposed for the track oval and chute. This bid should not include the pole vault landing pits/foam padding and standards. Location of the pole vault area per attached diagram.
- E. The construction of **one or two** shotput throwing surface, toe board and markings according to NFHS guidelines. The construction of the throwing area complete with outside boundary edging of an appropriate material. This bid should include the cost of raising, leveling and compacting the base to the throwing surface and throwing area. Location of the shotput areas per attached diagram. The board will consider installing either a single area OR a double area. This bid is not a bid for three areas so the bids should be separate for proper consideration.
- F. The combination of Bids A, B, C, D and E with any discounts included for combining all track, high jump, long jump, shot put and pole vault renovations at this time.
- This request for proposals is separated out to allow the Board of Education to consider improvements that will fit into our budget. While all bid requirements must be complete and agreed upon for Proposals A, B, C, D, E, and F, bidders do not have to make proposals for all sections [A(1), A(2), A(3), A(4), B, C, D, E, and F] to be considered. For example a bidder may include proposals only for Section A(1), B and E and still be considered.
- Basically, we need to improve our track running surface and enlarge our high jump area. We would also like to be able to consider adding a long jump/triple jump area, add at least one shot put area and consider adding a pole vault area. Ultimately if our budget allows we will make all improvements.
- The Board requests a reference list by November 4<sup>th</sup> of at least area three tracks with the identical surfaces that you are bidding. This will allow them to better consider each bid at the School Board Meeting.

#### **INSTALLATION OF WORK**

All procedures connected with the installation of the running surface shall be in strict accordance with the recommendation and requirements of the manufacturer as described within the scope of work below.

The surface contractor shall have a minimum of five (5) years installation experience and shall provide proof of completing similar jobs including references. Please include the address and phone number of the contact person of at least five (5) references.

Those wishing to bid products or provide substitutions other than those specified by the U.S.D. 307 must submit for approval at least seven (7) days prior to the bid date. Approval of specifications other than those specified does not constitute acceptance of the final bid by U.S.D. 307.

This project must be completed between June 1, 2023 and March 1, 2024 and should be planned as to not disrupt the normal school activities and procedures.

#### SCOPE OF WORK

The contract work to be performed under these specifications consists of furnishing all of the required labor, materials, parts and supplies necessary for the base repair, preparation and installation on a 6 lane running track and field event surfaces in accordance with these specifications and conforming to standards for running track and field event construction and repair. All lines, starting lines, and event markers must be clearly and accurately marked/painted according to the National Federation of State High Schools Association (NFHS) rules.

#### **GENERAL**

I. All construction must meet NFHS Specifications unless otherwise noted or approved by the U.S.D.

- II. Quality assurance-:
  - A. Manufacturer must have a minimum of five years of experience in the construction of tracks and track surfaces.
  - B. All construction and applications must be done by certified and/or qualified personnel.
  - C. All materials must be approved and high quality for their purpose and the purpose of the facility.
  - D. The contractor/bidder will supply the manufacturer with all state, local, and ADA codes and regulations.
  - E. The bidder/contractor will provide the U.S.D with detailed plans for the repair and construction when submitting the bid.

#### III. Warranty:

There will be a minimum of a five-year warranty on the product and workmanship in relation to it being free from defects in materials and workmanship beginning with the date that the product is completed at the job site. Contractor shall provide a written warranty for the surface installation and paint striping/lettering against faulty materials or workmanship for a period of five (5) years from the date of acceptance from the Owner (U.S.D. 307). This is in addition to the base repair crack warranty. All defects occurring within the warranty period for the surface installation and paint striping/lettering of the track and crack repair of the base shall be promptly repaired upon written notification from the owner, at no cost to the owner. The surface will resist wear and tear normal for the designated uses as well as degradation from microorganisms, rot, mildew and fungus.

#### IV. Manufacturers Requirements:

All materials and equipment supplied shall be installed, applied, or erected in strict accordance with manufacturer's trade association requirements unless technical specifications bound within this bid sheet exceed those requirements, methods or procedures set forth in manufacturer's recommendations.

If the contractor/bidder finds the RFP requirements unacceptable or unclear, they shall submit a letter to the superintendent to clarify those requirements. The Superintendent will determine if the Request for Proposals needs to be changed and notify all known bidders.

#### V. Verification of Dimensions:

It shall be the responsibility of the contractor/bidder to site verify all dimensions and conditions at Ell-Saline Junior/Senior High School located at 414 E Anderson, Brookville, KS 67425, before submitting a proposal/bid and before fabrication or installing equipment or materials. #### VI. Materials, Equipment, and Substitutions;

Where items of equipment and/or materials are specifically identified by a manufacturer's name, model, or catalog number, only specified items may be used in the base bid except as hereinafter provided.

#### VII. Temporary Equipment Facilities;

The contractor/bidder shall provide for their own use, temporary walks, runways, scaffolding, shoring, bracing hoisting and any other equipment required for the proper progress of their work and remove same at work completion. The U.S.D.'s restrooms may be utilized by the workers, as long as they are left in an orderly manner and all possible means are used in order to keep debris from being tracked in the building. Workers using inappropriate or vulgar language while on district property will be asked to leave the premises.

#### PRODUCTS

- I. Product features
  - a. Repair asphalt base as needed in a manner that addresses existing cracks and defects warranted for a period of no less than five years from the time of installation of the new track surface. If the proposal does not require repairing or replacing the substructure of the track, then the surface area will be warranted for the period of no less than five years from the time of the installation including future substructure repairs that negatively affect the surface area.

- II. Materials and Finishes

All materials and finishes will have the ability to withstand weather conditions that are normal to the extremes that make up the Kansas climate.

III. Design Loads. Normal design loads. Exceeded in all cases.

All design load conditions will meet or exceed normal conditions of those for the use of the construction and that are normal to the extremes that make up the Kansas climate.

#### EXECUTION

I. Installation:

- Bidder/contractor shall use factory trained installers.
- Bidder/contractor shall conduct the repair, construction and installation in accordance with the manufacturer's detailed installation procedures and State and County regulations.
- Care shall be taken not to interrupt the daily operation of the buildings. Work shall be scheduled so that the building will be left watertight and premises will be left clean at the end of each day. Care shall be taken not to damage school district property and facilities.
- The District's representative will periodically examine the work in progress, as well as upon completion in order to ascertain the extent to which materials and procedures conform to the requirements of these specifications. The presence of the District's representative shall in no way relieve the contractor of his contractual responsibilities.

#### SITE PREPARATION

• Site preparation shall be coordinated with the U.S.D. so as to not disrupt the daily operation of the buildings.

#### **RECEIVE AND STORE EQUIPMENT AND MATERIALS**

The storage of materials, tools, and equipment on the building site is to be done in such a way as to not impede progress of construction or the work. Track contractor shall provide water proof storage required for his use, such storage shall not be at a locations that is objectionable to the District. Any off-site storage facility used shall have proper insurance protecting the contents from all loss. Evidence of this insurance shall be produced prior to request for payment of any stored materials. Storage of materials on site will be stored in a location as to not impede the daily operations of the school district.

**PERMITS AND CODES:** The bidder shall be responsible for acquiring contractor's license, permits, etc., required for all work involved in the project. All work shall comply with all local, state, and federal laws, ordinances, and regulations as well as the most recent Uniform Building Code (UBC) if applicable.

**INSURANCE;** A certificate of insurance will be required before work begins showing that the contractor has insurance of the type and amounts as follows:

- 1. Workman's compensation insurance equal to or to exceed government requirements adequate for all their employees. The contractor shall require any subcontractor to provide similar insurance unless covered by the contractor's insurance policy.
